Since July 2019 the Company has been responsible for the organization of electricity trading on the DAY-AHEAD MARKET and INTRADAY MARKET

The Company operates **TRANSPARENTLY** in compliance with the principles of free pricing

Electricity auctions are conducted **24/7 in AUTOMATIC MODE**, without any manual process control



The price on the day-ahead market is determined by the principle of **volume maximization and price minimization**. No participant sees stated prices for either the sale or purchase of electricity

This technology of auction on the day-ahead market contributes to the development of competition

The intraday market allows market participants to adjust their trading positions and works on the principle of "each product has its own buyer." That is, sellers contract the volumes and prices at which they want to sell electricity, and wait for their buyer

«Market Operator» operates on the exchange principle, which promotes to competition and lowers an electricity price.

The company enables electricity market participants to minimize imbalances and thus reduce their costs.

It is the first and only state company in Ukraine which introduce payments through ESCROU accounts. And first, who has the payroll system working at the weekend.

The «Market Operator» provides instant 100% calculations between those who sold and those who bought electricity, which prevents the emergence of debt in these segments of the new energy market.












WEIGHTED AVERAGE PRICES ON THE DAM FOR 6 MONTHS OF 2019






WEIGHTED AVERAGE PRICE ON THE DAM





WEIGHTED AVERAGE PRICE ON THE IDM





The prices for DAM and IDM are regulated by the market. The weighted average price is formed and based on supply and demand for the sale of electricity. If in the first month of operation of the new energy market of Ukraine the average weighted price was 1 643.48 UAH/MWh (excluding VAT), in December the producers and buyers already accepted the electricity at the price of 1239,05 UAH/MWh (excluding VAT). After six months, prices have been fallen by almost 25% under the influence of market factors and relatively warm winter.




DEVIATION OF AVERAGE HOURLY PRICES FROM PRICE CAPS

For the first four months of the new energy market, hourly purchase-sale prices of electricity on the DAM both in the IPS of Ukraine and in the Burshtyn Power Island were mostly close to the price caps of the Regulator. The trend has changed in the last two months of 2019, and the prices on the DAM were much lower than the price caps.






